The City Manager informed Council a delinquent property tax notice has been sent to Mr. Hussie. Based upon the amount of taxes this property will not be on the top of the list for tax sales.

The City Attorney stated the amount of the County taxes due is \$2,040.

Staff's recommendation is to adopt a resolution directing the property owner to either repair or demolish the structure within forty five (45) days.

#### REQUEST - KEITH DAVIDSON - EXTENSION 4 AND 6 ST CLAIR STREET

The City Manager informed Council that staff was a day or two away (a work order and disconnect notices had been issued) from demolishing the structure. Mr. Davidson informed him he had closed on the property and is ready to do the repairs. When he came to obtain a permit for the repairs he was informed he would have to receive an extension from Council and the Board of Appeals due to the structure being unoccupied for a time period and that the legal non-conformance status has expired. This structure is an apartment complex in a single family zoned residential area. He has made an application to appear before the Board of Appeals at their next meeting.

Mr. Keith Davidson indicated in April he asked for an extension of sixty days and it has been about eighty days. He was not notified of the July 8, 2014 meeting. The property was owned by two separate Trusts which delayed the closing. This has been corrected noting he has closed on the property and is ready to move forward with repairs. He did not know the structure would revert back to single family after six months. He learned of this when he came to purchase a building permit.

Mayor Brady indicated someone knew about this and did not inform Mr. Davidson. He has closed on property that needs at least two issues corrected before moving forward.

Mr. Davidson stated they are not changing anything. They are planning to spend at least \$80,000 on renovations.

The City Manager has an email from Mr. Pridgen including Dean Smith and Mr. Davidson on March 20, 2014. On March 23, Mr. Davidson responded to Mr. Smith on the nonconformance status and the stream buffers.

Motion by Mayor Pro Tem Jenkins, seconded by Councilman DuBose to approve an extension for 4 & 6 St Clair Street until the September 9, 2014 meeting
